by MPNA and JNA for a meeting and only reached out to the previous HDRC representative for a recommendation. Upon hearing of the new appointment, MPNA and representatives from JNA met with D7 Councilman on 12/21/2015 and expressed the following concerns:

Are MPNA requests being ignored?

Was the Councilman's appointee qualified for the position (knowledge of UDC guidelines/process)? Were any expectations of appointee's and/or goals identified?

And what is the Councilman's overall commitment to historic preservation?

As a conclusion MPNA, asked for the following:

- Provide a copy of appointee's resume and application
- Provide the date Council will be approving the appointment
- That the Councilman would remove the appointed individual if more than two consecutive HDRC meetings are missed per UDC rules (he agreed)
- Send a list of expectations the Councilman has for the HDRC representative to MPNA and JNA.
- Attend the next MPNA General Assembly meeting with OHP. As of publication of this email no additional communications have been received from the Councilman.

2202 Fredericksburg Road: The building is now vacant and a permit was applied for on 12/8/2015 for new construction. The permit states the new commercial building will be 1856 sq ft and have a value of \$169K. MPNA still has not seen the agreement Councilman Trevino (D1) signed with the landowner instead of designating the property historic. This concern was raised to the D7 Councilman on 11/30/2015 and again on 12/21/2015. No additional information has been received by MPNA.

3114 Fredericksburg Road: The old hand carwash was demolished. A new carwash tunnel is under construction.

HEB featured speaker for the MPNA General Assembly: Come learn about how HEB, Deco District HEB, is responding to your concerns, security, HEB new app, coupons, upcoming property improvements, and how to get your favorites on the shelf. MPNA reached out to HEB to be more involved in our neighborhood store and express our concerns. They want to hear from you!

Graffiti Clean up: Saturday February 20th at 9am. Meet at 444 Club Dr. We will have supplies for you!

Upcoming infrastructure improvements in 2016 from the City of San Antonio annual Budget:

- 1) Mary Louise/ Furr Alley from Vollum to Shearer will be paved and foundation repaired. The City will be performing the work and also perform a ONE time trimming of alley vegetation.
- 2) 100-500 blocks of Club Dr will be resurfaced and new sidewalks and curbs.
- 3) San Antonio from Fredericksburg and W. French resurfacing is finishing up.


Join MPNA Neighbors for the "Pink Flamingo" Happy Hour

From the *Code Connection*, the newsletter from the Code Enforcement Section, Development Services Department:

Absentee Property Owners


On Sept. 19, 2013, City Council passed the Absentee Property Owner (APO) Registration ordinance. Someone who owns a one- or two-family (a duplex) dwelling and resides outside of Bexar County, or has a P.O. Box on file with the Bexar County Appraisal District (BCAD), is considered to be an APO. To be identified for registration, the Development Services Department (DSD) uses a rolling one-year window to find properties having two or more code violations within the past 12 months. Once identified, these properties must register for a minimum of two years and pay a \$50 annual registration fee. In addition, contact information for a local property manager – who can act as an agent on behalf of the property owner – must be provided by the APO so future violations are addressed faster and more efficiently. If properties continue to have violations, then annual registration continues to apply. Before this ordinance was approved, APOs were found to be 30% more likely to have a code violation and 70% more likely to have a lien placed on the property due to non-compliance and non-payment of abatement costs covered by the City.

Since implementation of this registration program, more than 1,000 properties have been identified. Close to 10% of these properties have a P.O. Box on file with the BCAD. Some APOs have shown that they live in San Antonio and have generally indicated that they use a P.O. Box to (a) collect rental payments from their tenants at a central location if multiple properties are involved or (b) desire to maintain their home address as "private" from tenants or other parties. Today, about 300 properties have been registered by APOs along with their first-year fee. Almost a third of these properties have already paid for their second year of registration.

Failure to register is a Class C misdemeanor, prosecuted in Municipal Court that can result in a criminal conviction or a warrant if the property owner doesn't appear. To date, we have filed on nearly 20 cases for failure to register and more than a third have been found guilty. Before a case is filed in Municipal Court, an APO's date of birth must be verified and submitted by the Code Enforcement Officer. However, this has posed a challenge since personal information for APOs living outside of Bexar County is difficult to locate and verify. Additional cases are being prepared to be filed in court. Our next step will be to evaluate whether this registration program is making a difference in our community. Has there has been a decrease in the number of code violations for properties identified as having APOs? Initial results show a decrease in code violations. For about 100 properties registered in 2014, there was a notable reduction six months after registration from 2.3 to 0.7 code violations. We'll look at these properties again, this time over a one-year timeframe, to determine if the decrease is maintained. DSD will also reach out to various stakeholders to obtain input as to whether communities across San Antonio have noticed a difference. This information, along with any recommended changes to the ordinance, will be presented to the City Council on September 15, 2016.
