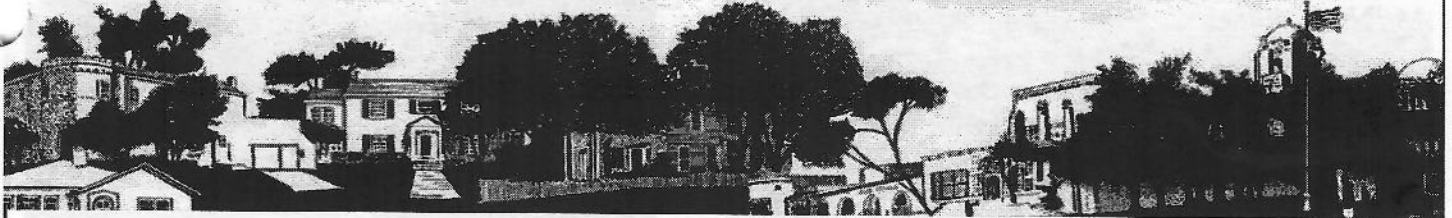

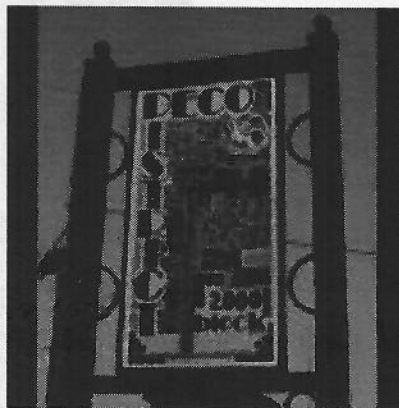

The Neighborhood

On June 27th, the City held the first of three public meetings for the "Fredericksburg Road Corridor Study and Design Strategy" commissioned by City Council. The boundaries for the study are Fredericksburg Road from Balcones Heights to I-10 and two blocks on either side of the street. The Study also includes the neighborhood boundaries for the Maverick Neighborhood Association, the only neighborhood included in its entirety. All properties designated Historic, even though they are on Fredericksburg Road, are excluded from the study. (See map of area of study) Fredericksburg Road has seen many changes since the Deco District was designated as an Urban Corridor in 1994. The last action by City Council limited signage height, billboards, and required screening for outdoor storage and unloading activities.



Consultants hired for the project are: Robert Yakas Design, Ximenes and Associates, and FCS Group. They have established the following goals for the 2016 Study: strengthen property values, improve physical appearance, improve property upkeep and maintenance, improve access for pedestrians/bicycles/transit, strengthen corridor and community identity, and increase resident satisfaction.

You Decide: Eventful or uneventful happenings in MPNA!

-Where is the rain? It seems as though it's feast or famine. Please be sure to water your trees!

-Alazan Creek Trail opened on Sat. 6/18! The trail begins at the Woodlawn Lake Casting Pond on Josephine Tobin and extends approximately a half mile south to Lombrano. The trail creates a safe pedestrian passage under Waverly and Culebra Streets furthermore connecting Woodlawn Lake Park and West End Park.

-1901 Fredericksburg Road: David Komet sent MPNA an email indicating it will not be feasible to begin development and new construction for the Insurance Business on the empty lot (corner of Fredericksburg/Elemendorf). Ultimately, there were several influencing factors regarding timing, monies, and setbacks for utilities which proved unsurmountable. We look forward to another design in the future and remain optimistic something new will come to the Deco District Corridor.

-An important message from the City's Solid Waste Management Division: "Beginning July 1, 2016 Residents who place garbage in the blue carts will be charged a \$25 fine. Please recycle correctly." 210.207.6428 www.sanantonio.gov/swmd.

-San Pedro Playhouse has a musical *The Best Little Whorehouse in Texas* featuring MPNA resident Bob Galindo and running until August 7th www.theplayhousesa.org.

-Monticello Park pocket park at 444 Club Drive- In May, a car jumped the curb on Kampmann and plowed some car tracks in the middle of the park. Therefore, mulch was used to fill the tire tracks placed in June. Also, a trashcan and the dispenser for the pet waste bags disappeared at the SE corner of the pocket park at the end of June. A call to the City's Parks and Rec Department yielded the following information. Parks and Rec Park Supervisor removed both items because a

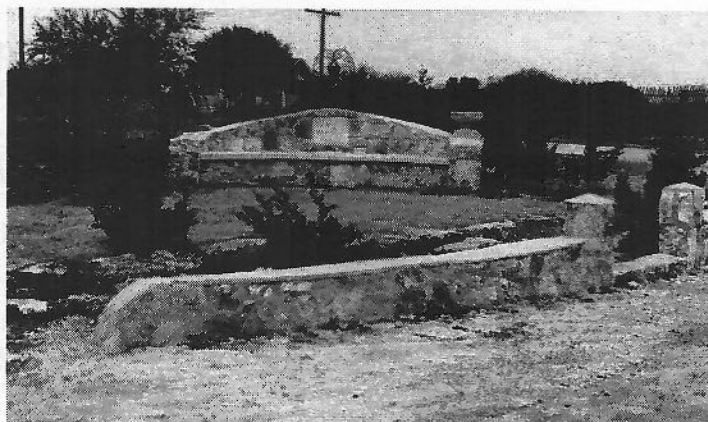

The first meeting began with an evaluation of existing conditions of the corridor: the good and the bad. The good are the historic buildings and structures, landscaping, updated architecture, neighborhood pedestrian connectivity, and signage marking the Deco District. The bad are multiple curb cuts, sidewalk gaps, drive thrus, no clear delineation between pedestrians and cars, power poles in the middle of sidewalks, lack of shade/landscaping, and lack of pedestrian safety measures. The consultant agreed that the new construction at 2202 Fredericksburg Road was a detriment to the pedestrian safety, and that the building's orientation turned its back to the corridor.



During the meeting, the corridor was split into three sections and all attendees were split into three work groups according to the area each resident lived near. The groups used colored dots and markers to identify areas of concern on their section of Fredericksburg Road: safety issues, lighting, sidewalks, and landscaping.

Afterwards, each group mentioned its main concern. Our group's main concern was our exclusion from the Study. Just because MPNA's boundaries on Fredericksburg Road are historic does not exempt its properties from infrastructure needs.

We have a "virtual" VIA Transit Center at Mary Louise and Fredericksburg Road, aged sidewalk infrastructure with lack of ADA accessibility, inconsistent lighting, and pedestrian safety issues too. Being designated a landmark property or a property within a historic district on Fredericksburg Road should not be an obstacle but an opportunity for uniform Right of Way and Street improvements. The City must include these properties within the study. As VIA continues to encroach with high-density pedestrian traffic into the MPNA community, there should be proper planning and infrastructure to avoid deterioration. Please join MPNA to voice concern to City Council!



MPNA is advocating for including all properties on Fredericksburg Road in the study, filling the sidewalk gaps, landscaping, signage overlay standards for the corridor, and pedestrian-friendly design standards for new construction.

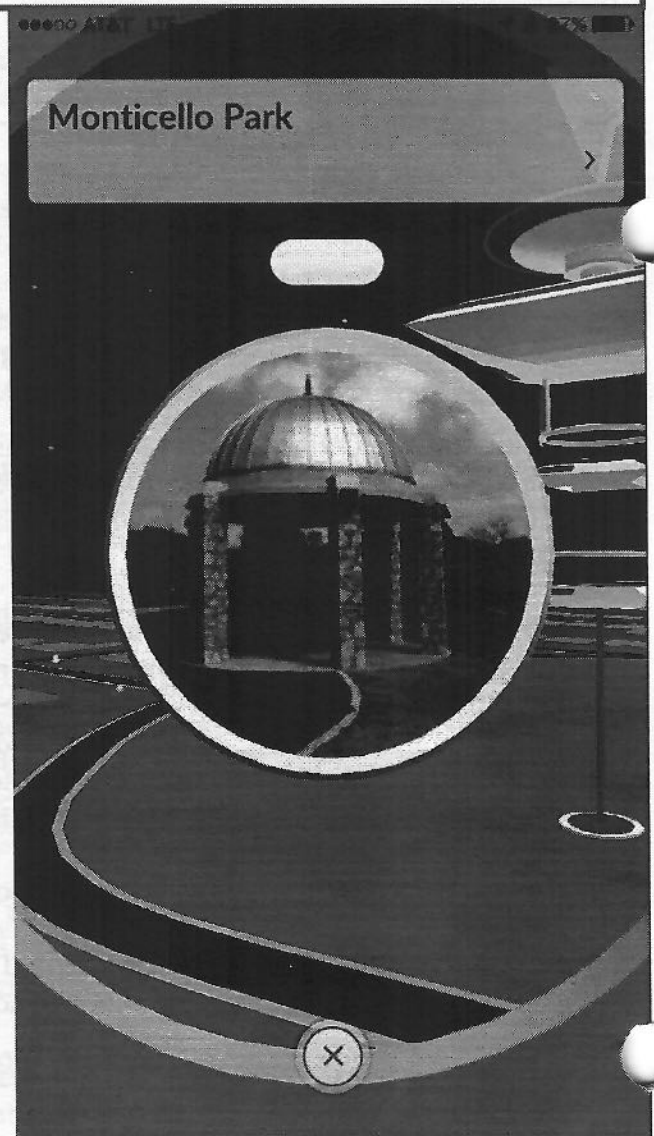
For those who will understand what in the world it means:

**Downtown, of course, seems to have a Pokestop every block, with the Alamo being a Pokegym.





Fredericksburg Road Corridor Study and Design Strategy

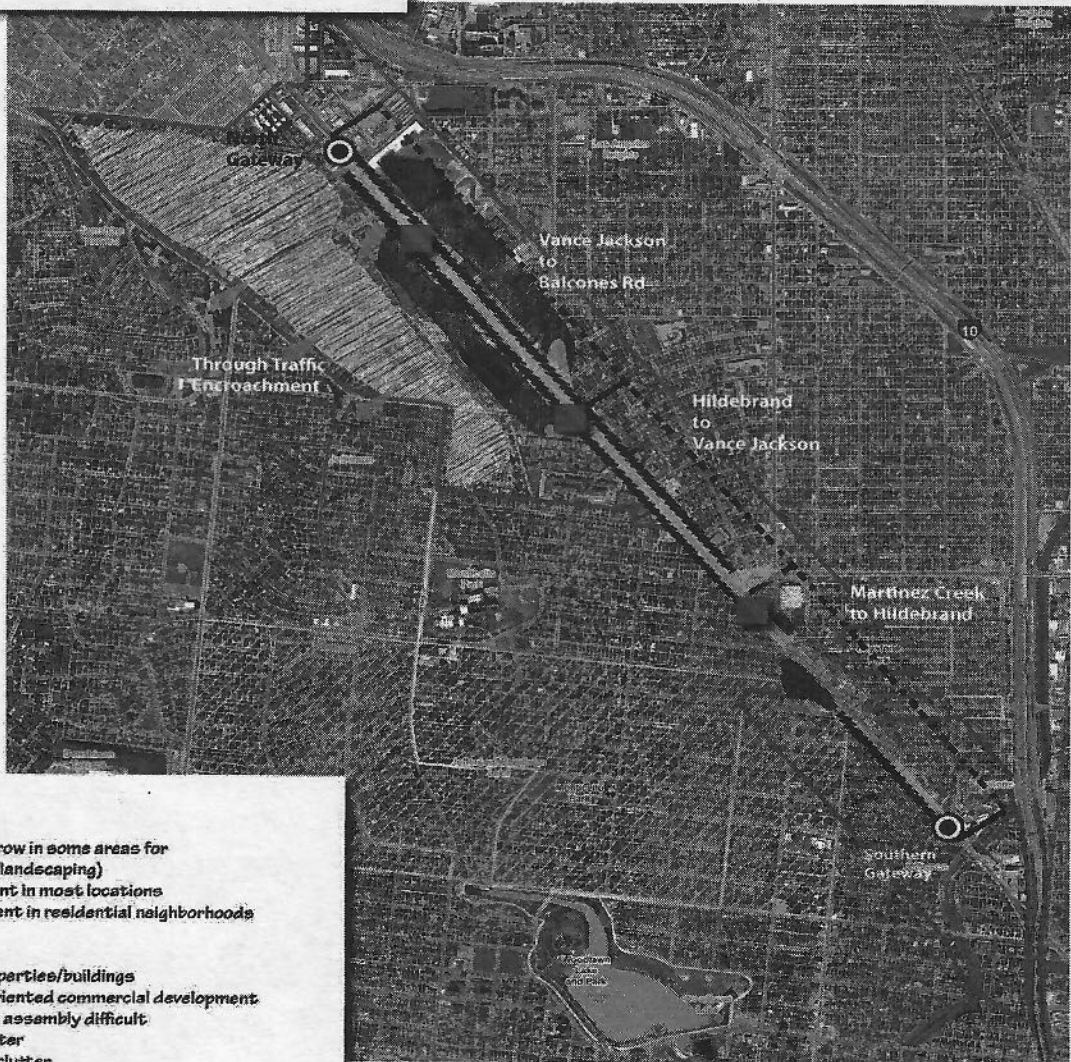

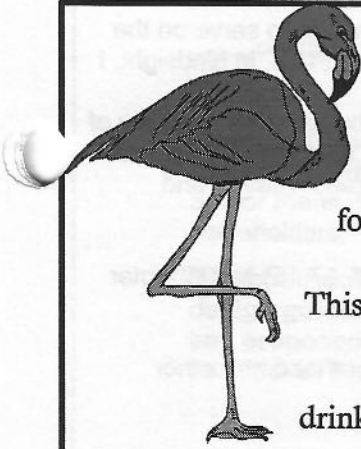

The SA Comprehensive Plan outlines the future policies and goals for our growing City. I was asked to serve on the Historic and Cultural Preservation Plan Element Work Group (PEWG) for the SA Comprehensive Plan. In hindsight, I wish I would have served on Housing PEWG after reading the entire plan and its blueprint. MPNA has serious concerns regarding the effect of the new Comprehensive Plan on our neighborhood and the City of San Antonio as a whole, especially as it relates to already existing Near NW Community Plan. The goals and policies and their priorities within the plan speak little to single family home retention and incentives for rehabilitation and restoration.

The plan draft is 375 pages and following are pages of concerns:

Chapter 1 (1.3), Chapter 8 (8.5, 8.7, 8.12), Chapter 10 (10.8, 10.10, 10.12), Chapter 17 (17.14 & 17.15) and Chapter 18 (18.2, 18.3, 18.7 & 18.8) are especially relevant.

Chapter 1 (1.3) and Chapter 17 (17.14) contradict each other as they relate to replacing Neighborhood and other Plans.

The Plan should be the best that it can be in planning for the future while protecting and preserving the neighborhoods, culture and history of the past. While planning for the next million people, it is important that the quality of life for the current 1.3 million be given equal treatment.

Neighborhood Concerns with the SA Comprehensive Plan:

WHAT DO SAN ANTONIO'S NEIGHBORHOODS WANT FROM THE CITY'S NEW MASTER PLAN?

The Comprehensive Plan Draft challenges neighborhoods by encouraging incentivized, high density infill development to mostly single family neighborhoods. Existing Neighborhood Plans, Community Plans, Sector Plans and Neighborhood Conservation District (NCD) Design Guidelines are vulnerable and some will be eliminated.

1. LACK OF NEIGHBORHOOD LEADERSHIP REPRESENTED IN THE DEVELOPMENT OF THE COMPREHENSIVE PLAN

When the City initiated the process for a new Master Plan in 2015, over 200 stakeholders served on 9 Plan Element Working Groups (PEWGs) which included Housing, Jobs, Military, Transportation, Public Facilities, Natural Resources, Community Health, Growth, and Historic & Cultural Preservation. San Antonio has 353 neighborhoods: only 5 individuals represented San Antonio's neighborhoods serving on one PEWG: These individuals were only invited and participated on the Historic and Cultural Preservation PEWG. Neighborhoods were not represented on the remaining 8 PEWGs where important planning decisions affecting neighborhoods were drafted into policies and goals.

Neighborhood Associations must be involved in a process where the context of existing plans, including land use plans, will change to add incentivized high density infill development. City staff maintains that there has been wide neighborhood participation in the Comprehensive Plan. Staff responds by stating people from different neighborhoods attended public presentations and therefore were involved.

The ability of having limited input is very different from having input on a Plan where there was no representation by neighborhoods experiencing the impact and effects of this Plan.

2. EXISTING NEIGHBORHOOD PLANS, COMMUNITY PLANS, NCD DESIGN GUIDELINES, SECTOR PLANS, MASTER PLANS, OVERLAY DISTRICTS, ETC. WILL BE ELIMINATED AND/OR REPLACED

The Comprehensive Plan Draft targets neighborhoods to accommodate the expected addition of 1.1 million new residents to the city. The SA Comprehensive Plan is being utilized as justification for monies in the 2017-2018 City Budget and 2017 \$850 Million Bond dollars to expand the incentives for higher density infill development and rezoning:

"New Community Plans will replace two plan types, neighborhood and community plans. New Community Plans should cover areas with a minimum of 10,000 residents and range in size from 15 to 30 Square miles" (Comprehensive Plan Draft, Sect.17-14).

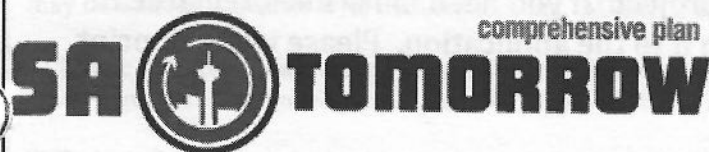
Since 1985, over 650 neighborhood stakeholders worked 18–24 months developing 37 Neighborhood Plans, nine Neighborhood Conservation Districts, 15 Community Plans and 32 neighborhood groupings plans, i.e. Sector Plans, Master Plans, Overlay Districts, etc. Many plans required five year updates and input from the stakeholders.

Neighborhood, Land Use, Community Plans, Sector Plans and Neighborhood Conservation District design guidelines, Master Plans, Overlay Districts, etc., must be UPDATED AND INCLUDED prior to any proposed Regional Plan, New Community Plans, Transportation Plan, Corridor Plans, Citywide Functional Plans, Sub-Area Plans or Specific Plan being developed or adopted!

3. THE COMPREHENSIVE PLAN DRAFT HAS NO FORMAL PROCESS FOR THE COMMUNITY TO SUBMIT INPUT OR OFFER REVISIONS.

Changes to the Plan Draft have been submitted to City Council staff after learning the Comprehensive Plan Draft eliminated years of hard work by over 650 neighborhood stakeholders. No date has been provided for the Comprehensive Plan Draft revisions. The SA Planning Commission is slated to approve the SA Comprehensive Plan on July 27th before City Council Approves it on August 4th.

A process to submit public comment and changes by neighborhood leadership and PEWG members is necessary in order for there to be representation by those who are most affected by many of the Comprehensive Plan Draft's target areas. Additional time is needed by the Planning Commission, City Council, the Public and neighborhood leadership to have input into the revised Comprehensive Plan.

Alleys, Streets, Sidewalks, and Traffic Calming initiatives in MPNA

The MPNA board is working with the City's Transportation and Capital Improvements on the following:

Here is the list of traffic and some other TCI open concerns. I just listed everything but for the MPNA board meeting #2, 3, 5, and 8. MPNA board meeting 6:30 PM 1800 Fredericksburg Rd park in back and enter through rear of building on Monday July 11. Thanks BM 210.385.6188

- 1) Mary Louise/ Furr Alley between San Antonio and Vollum was scheduled for work on the Infrastructure Maintenance Program for 2016 and was removed. MPNA is awaiting a response to reschedule. Conveniently TCI has no documentation of it being scheduled but MPNA has a hard copy of the original schedule.
- 2) Traffic reconfiguration at Club Dr, Fredericksburg Rd and W. Hildebrand for vehicular and pedestrian safety. TCI is studying the traffic flow through this intersection. Recommendations are expected in 90-120 days.
- 3) HEB/Mary Louise/Fredericksburg Rd intersection- Cars exiting the HEB at light turning westbound on to Fredericksburg Rd should have a NO TURN on Red. This was promised to MPNA by VIA but never was posted. MPNA is working with TCI and VIA to have it installed.
- 4) New Historic District Street Sign at Furr Drive and Fredericksburg says "Furr Road" should be Furr Drive. Sign has been corrected
- 5) 4-way stop sign at North Drive and Lake Blvd is being evaluated for ensuring which vehicle has the right of way and address line of sight issues. Please note stop signs are not used by the City to address speeding.
- 6) Rubber Speed Humps on Club Drive will be removed. Asphalt speed humps will go back in their place on Club Dr but may be solid or baguettes style with separations. MPNA is awaiting final decision from TCI.
- 7) Traffic Calming initiatives for Kampmann to reduce speeding around curves. MPNA will be filling out a traffic calming study request and will need property owner support to have TCI evaluate and offer suggestions.
- 8) Parking Restrictions for parking at the curb for the 1100-1300 blocks of Kampmann (from Mary Louise to North Dr). MPNA met with TCI and SAISD to receive support of no parking at the curb from 7-9AM and 2-5PM School days only on both sides of these blocks. This is to ensure all day parking at the curb is curtailed by TJHS.
- 9) IMP schedule to fill in the gaps of sidewalk on Lake Boulevard. MPNA needs sidewalks between Donaldson Avenue to Mary Louise: 3 homes need a sidewalk on their side yards. Sidewalk only on Westside on Lake Boulevard. Awaiting scheduling.
- 10) Mary Louise/ Club Alley between Lake and Vollum was removed from the IMP. Flooding at 3 homes is extreme and demands regarding for proper drainage. MPNA is waiting on TCI to reschedule on the IMP. We have documentation of its removal from the IMP.
- 11) IMP to schedule roadway repair from 200-500 blocks of Donaldson Avenue. VIA bus route, low PCI scores, several severe water leaks some in multiple locations, and street was also zippered cut. SAWS needs to do water main repairs and should also be held accountable for street repair as they have a direct impact on the deteriorated rate of street for multiple penetrations. This was also the main route for construction traffic at TJHS.
- 12) Straightening of street signs and update of faded historic district street signs over 25 intersections were reported. Awaiting updates on all. The City has a large order of stop signs on back order. You may have noticed some replaced recently and this is in anticipation of school starting. More information to come.
- 13) Alley on the 300 block of North/300 block of Quentin was removed from the IMP and MPNA is requesting that it be scheduled for 2018 to match the 2 alleys directly east: do the entire alley at one time.
- 14) Traffic Calming initiatives-MPNA will be reaching out to additional residents for locations where speeding is occurring during the month of August.

Helping our students achieve greatness through professional attire

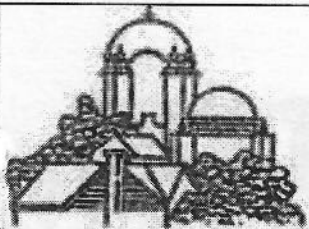

Our students and parents are committed to breaking the cycle of poverty and disadvantage that many of them have lived in for generations. In addition, on Monday of each week everyone attending school, including faculty and staff will dress in "Professional Wear". 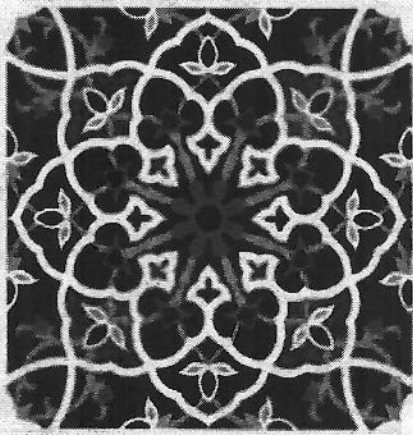

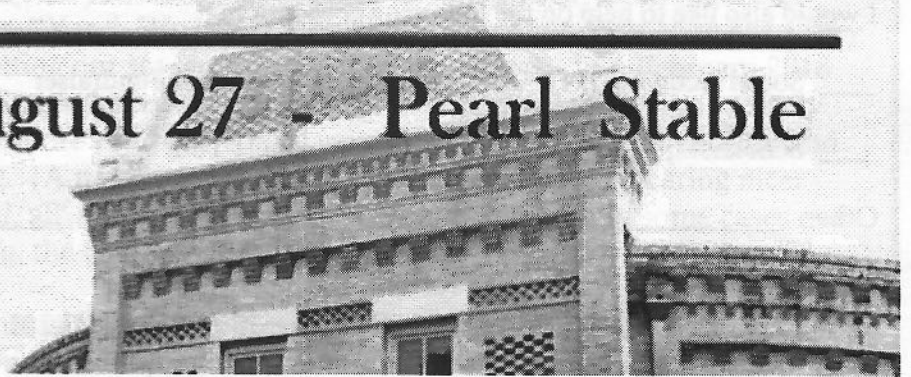
